- 4. Electronically bids must be submitted to the office through www.bolpatra.gov.np/egp on or before 12:00 on 2077/12/05 (2020/03/18). Bids received after this deadline will be rejected.
- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00, 2077/12/05 (2020/03/18) at the office of Sangurigadhi Rural Municipality. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amount as stated above deposited at Dharauti account No. 0520000841 on behalf of Sangurigadhi Rural Municipality at Nepal Bangladesh Bank Ltd ,Sangurigadhi Branch or bid bond authorized from a recognized "A" class commercial bank or Financial institution eligible to issue bank guarantee as per prevailing law of Nepal. A scanned copy of the bid security in pdf format, amounting to a minimum of Nrs. 60,000.00 which shall be valid for 30 days beyond the validity period of the bid.
- 6. If the last date of purchasing or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
