The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 , 2076/08/03 (2019/11/19). the office of Sangurigadhi Rural Municipality, Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. 48,000.00 which shall be valid for 30 days beyond the validity period of the bid.
6. Bid must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amount deposited at Dharauti Khata A/C No. 0520000841 on the behalf of Sangurigadhi Rural Municipality at Nepal Bangladesh Bank Ltd ,Sangurigadhi Branch. or Bidder who choose to submit their bid security amount as Bid bond ,the bid bond should be issued from authorized and recognized commercial bank or Financial institution eligible to issue bank guarantee as per prevailing law of Nepal. A scan copy of bid bond is mandatory.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Bid should comply in all respects with the Instruction to Bidder included in the bid document no compliance with this instruction shall result in disqualification.
